Because they have forgotten over 80% of small business becomes their own registered agent, while greater than 80% of major business seek out registered agent(s). A registered agent is a person or service who will receive legal documents on behalf of your business, such as subpoenas, regulatory and tax notices, and correspondence. In many states, lawsuits must be served in person. Having a registered agent makes this a clear and orderly process. Registered agent business services are widely different, depending upon the agency. USNEPS offer a full service, plus grant writing (and underwriting) services to member of our agent services division, and for religious orders. ### What is a Registered Agent?

A Missouri registered agent is the legally designated point of contact for your business or nonprofit. The registered agent receives important legal notices, such as service of process (aka notice of lawsuit), on your business. The key benefits.

- A clear designated place to receive official legal documents, such as lawsuit papers, subpoenas, and other legal notices,
- 2. Grant support services, and
- 3. General legal research services.

We take 50 cases each year for *Pro Se support* (free of charge). Local churches get free ecclesiastical support every Saturday of the month (members only).
