#### "Why do I need a virtual grant writer?

Grants can be an excellent way to get funding to your organization and can make a significant impact on its' ability to excel. Obtaining a grant is not easy though, you must turn in a proposal that will wow the agency offering the grant, and there is usually pretty stiff competition. Only eight percent of grant proposals receive funding, and with odds like that, this is not something you want to DIY. #### What is a Grant Writer?

Grant writers research, draft, and submit proposals that help organizations or individuals receive grant funding. To be eligible for funding, an organization or individual must have an objective that aligns with a grant's specifications. Many grant writers, like USNEPS, work for for-profit & nonprofit or charitable organizations. The key benefits.
